In consideration for being permitted to participate in the Cities of Riverside & San Bernardino (hereafter referred to as "CITIES") Adult Hardball Program (I.E.A.H.L.), I hereby agree for myself, my heirs, administrators, executors, and assigns to release, waive, hold harmless and indemnify Major League Softball, Inc., its officers, representatives, umpires, scorekeepers, and volunteers, as well as the CITIES, its elected officials, members of Boards and Commissions, officers, employees, agents, representatives, and volunteers from any and all liability, claims, and actions for any injury, death or damage to personal property arising out of or in connection with my participation in the Adult Hardball Program (I.E.A.H.L.) from whatever the cause, including but not limited to, those enumerated in the California Government Code, the active or passive negligence of Major League Softball, Inc., or the CITIES, and either parties' offices, employees, agents, representatives, umpires, scorekeepers, or volunteers.
